INCREASING THE PASWI'S ONE-TIME MEMBERSHIP FEE FROM FIVE HUNDRED FIFTY PESOS (P550.00) TO SIX HUNDRED PESOS (P600.00) AND TO BE PAID SEPARATELY THE IDENTIFICATION CARD FEE IN THE AMOUNT OF TWO HUNDRED PESOS (P200.00) AND ANNUAL MEMBERSHIP DUES FROM THREE HUNDRED FIFTY PESOS (P350.00) TO SIX HUNDRED PESOS (P600.00) EFFECTIVE JANUARY 2023

WHEREAS, the present amount of the one-time PASWI membership fee is Five Hundred Fifty Pesos (P550.00) inclusive of the identification card fee, whereas that of the annual membership due is Three Hundred Fifty Pesos (P350.00) both of which amount were adopted more than 30 years ago;

WHEREAS, it is of common knowledge that since its adoption more than 30 years ago, the costs of office operational expenses particularly office supplies, utilities, electrical cost, as well as the employment salaries and benefits have more than doubled;

WHEREAS, to enable PASWI to cope with the increases in all the foregoing operational expenses and more effectively fulfill its functions as a national organization, it is the considered decision of the PASWI Board that its one-time PASWI membership fee be increased from Five Hundred Fifty Pesos (P550.00) to Six Hundred Pesos (P600.00) and its annual membership dues of Three Hundred Fifty Pesos (P350.00) be increased to Six Hundred Pesos (P600.00); on the other hand, the Identification Card fee of Fifty Pesos (P50.00) which was originally incorporated in the one-time membership fee is now to be increased to Two Hundred Pesos (P200.00) to be paid separately effective January 2023.

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, that the increase of the one-time PASWI membership fee from Five Hundred Fifty Pesos (P550.00) to Six Hundred Pesos (P600.00) and to be paid separately the Identification Card fee in the amount of Two Hundred Pesos (P200.00), and annual membership dues of Three Hundred Fifty Pesos (P350.00) to Six Hundred Pesos (P600.00) effective January 2023.

RESOLVED FURTHER to furnish copies of this Resolution to all PASWI local chapters for their information and strict compliance.
