**CATEGORIZING PASWI MEMBERSHIP BASED ON ACTIVE PARTICIPATION IN PASWI ACTIVITIES AND NON-DELINQUENCY IN THE PAYMENT OF ALL PASWI FEES AND DUES**

**WHEREAS**, there is a need to categorize the nationwide membership in the Philippine Association of Social Workers, Inc. (PASWI) to arrive at a reasonable and fair classification of its members depending on their attendance of and active participation in PASWI’s national conventions and other activities, as well as in the activities, projects, and undertakings of their local chapters and their fulfillment of membership requirements such as being up-to-date in the payment of their financial obligations to PASWI;

**NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED** that PASWI membership, based on records, be categorized as follows:

1. Regular Membership –
  - 1a. Members who are active in their attendance of PASWI national conventions and other activities and in their participation thereof based on the PASWI national office records;
  - 1b. Members who are non-delinquent in the payment of PASWI fees and dues;
  
2. Inactive Membership –
  - 2a. Members who have failed without justifiable cause to attend the national convention and activities for two (2) consecutive years;
  - 2b. Members who have failed to pay their PASWI fees and dues for two (2) consecutive years;


**RESOLVED FURTHER** to furnish copies of this Resolution to all PASWI local chapters for their information and strict compliance.
